### **QLDC District Plan Variation Priority Area Landscape Schedules Late Section 274 Application**

The Society held a committee meeting two days ago where, among other things, it discussed the upcoming mediation for the Priority Area Landscape Schedules (PALS) appeals.

As chairperson I explained that the Society had decided to apply to become a S.274 party to only one PALS appeal in September 2024, the Glendhu Bay Trustees appeal<sup>1</sup>. This was because the Society's bank balance was in a parlous state at that time, and so it could not afford the \$1760 cost of joining all 16 appeals. Such are the travails of a small community group.

Since then the Society has been the beneficiary of some generous donations following its involvement in the Second Star Ltd. (Peter Thiel) resource consent application.

Discussion at the committee meeting reached a unanimous conclusion that, given the Society's improved financial state, it would be more consistent with the Society's position on the Proposed District Plan over the past twelve years to become a S.274 party to all of the PALS appeals in relation to the Topic 1-Preamble issue.

The Society considers that the amendments proposed to the preamble are likely to severely limit the effectiveness of the PALS. It considers that these amendments are contrary to the findings of the Court's decisions.

For this reason the Society is now making an application<sup>2</sup> to become a S.274 party to the following 13 appeals (in addition to the Glendhu Bay Trustees appeal):

While the Society accepts that this is a very late and unusual application, it considers that no party will be prejudiced. This is because the Society's position on all 14 appeals (as stated in both S.274 applications) is to support "the decision of the Council in its entirety."

## **Topic 2**

The Society has been listed to attend the Topic 2 mediation on 26 to 30 May. The Society seeks to withdraw from the Topic 2 issue and will not be attending the Topic 2 mediation.
