- 1 Mount Cardrona Station Limited (**MCSL**) wishes to be a party to the following proceedings, pursuant to section 274 of the Act:

*Mee Holdings Limited v Queenstown Lakes District Council* being an appeal under clause 14 of schedule 1 of the Act in relation to the Priority Area Landscape Schedules Variation to the Queenstown Lakes PDP (**Variation**) (ENV-2024-CHC-059) (**Appeal**).

- 2 MCSL made submission #124 and further submission #231 about the subject matter of the Appeal.
- 3 MCSL made an appeal to the Environment Court in relation to the Variation (referenced as ENV-2024-CHC-060).
- 4 MCSL has an interest in the Appeal that is greater than the interest the general public has because they have an interest in land affected by the Variation.

  - (a) MCSL opposes the Variation in its current form; and
  - (b) The Appeal seeks similar relief to that of MCSL's original submission #124.
- 8 MCSL agrees to participate in mediation or other alternative dispute resolution of the proceedings.
