## **Minute of the District Licensing Committee**

### **What do I need to do?**

You must file your submission and all of your supporting documents in advance of the hearing within the timetable set out in this minute.

### **When do I need to file evidence?**

Applicants must file written submissions and other supporting documents with the DLC **by 3pm Wednesday 24 September 2025**. Copies of this information will be provided to all parties to this application the same day.

Police, the Medical Officer of Health and Objectors who have confirmed their attendance must file written submissions and other supporting documents with the DLC **by 5pm Monday 29 September 2025**. Copies of information received from these parties will be sent to the applicant on Tuesday 30 September 2025.

As there is no ability to cross examine other parties, the DLC may ask questions on behalf of each party. Questions to the DLC regarding information provided in the submissions and supporting documents, must be filed with the DLC **by 5pm Thursday 2 October 2025**.

**Any additional information regarding timetabling of matters each day will follow in due course and be provided to parties in advance of the hearing.**

If you cannot comply with the timetable above, you must make a written application to the District Licensing Committee to vary it urgently. Any application must be made in a timely manner. Any such application will be referred to the Chairperson for directions and response.

The hearing will commence at the time and date set out in the Notice of Hearing.
