Adoption of Navigation Safety Bylaw 2025 | Te Ture ā-Rohe mō te Haumarū Whakatere 2025

Queenstown Lakes District Council has adopted a new Navigation Safety Bylaw 2025.

The new bylaw comes into force 20 March 2025 and replaces the previous Navigation Safety Bylaw 2018. The bylaw manages navigation safety on the district's navigable waters and foreshore so everyone can safely enjoy water activities.
